ADVISORY INFORMATION

This Extension of Authorisation relates to the use of 'Avadex Excel 15G' (M17872) on the listed crop which was formerly authorised under the Long Term Arrangements for Extension of Use. This notice sets out the full conditions of the agreed extrapolation.

Applications are to be made via approved granule applicators only (see product label for details).

APPENDIX 1: CONDITIONS OF EXTENSION OF AUTHORISATION

The conditions below are obligatory. They must be complied with when the Extension of authorisation occurs. Failure to comply with the following conditions will result in the withdrawal or amendment of the Extension of authorisation under Regulation (EC) No 1107/2009 and may result in other enforcement action, including prosecution. For the purposes of this Extension of authorisation only, the conditions and/or requirements shown below supersede any corresponding conditions and/or requirements set out on the label or otherwise provided for under the product authorisation **which would otherwise apply**.

Operator Protection:

- (1) Engineering control of operator exposure must be used where reasonably practicable in addition to the following personal protective equipment:

Operators must wear suitable protective clothing (coveralls) and suitable protective gloves when handling the product or handling contaminated surfaces.

- (2) However, engineering controls may replace personal protective equipment if a COSHH assessment shows that they provide an equal or higher standard of protection.

Environmental protection:

- (1) Crops/situations with >5m buffer zone:

Since there is a risk to aquatic life from use, do not allow granules from application equipment to fall within the distance specified for the crop of the top of the bank of any static or flowing waterbody or within 1m of the top of a ditch which is dry at the time of application.

- (2) Buffer zones must be measured in accordance with the guidance set out in the booklet 'Local Environment Risk Assessment for Pesticides - Horizontal Boom Sprayers' available from HSE Chemicals Regulation Division's website and any amendments made to it.
- (3) The results of the LERAP must be recorded in written form and must be available for a period of three years for inspection to any person entitled to exercise enforcement powers under or in connection with the Plant Protection Products Regulations 2011 or the Plant Protection Products (Sustainable Use) Regulations 2012. (An electronic record will satisfy the requirement for a written record, providing it is similarly available for inspection and can be copied).

Other specific restrictions:

- (1) When used on crops/situations with a greater than 5m aquatic buffer zone this product must not be applied via hand-held equipment.
- (2) This product must only be applied in accordance with the terms of this extension of authorisation, the product label and/or leaflet and any additional guidance on extensions of authorisation.
- (3) The seed or any part of treated plants must not be used for human or animal food or feed (except game birds).

APPENDIX 2: GENERAL CONDITIONS FOR AN EXTENSION OF AUTHORISATION

Failure to comply with the following conditions will result in the withdrawal or amendment of the Extension of authorisation under Regulation (EC) No 1107/2009 and may result in other enforcement action, including prosecution.

Adverse effects:

The authorisation holder must immediately notify the Secretary of State, the Scottish Ministers and the Department of Agriculture and Rural Development in Northern Ireland (care of the Health and Safety Executive), if they have any new information on the potentially adverse effects of the authorised product, or of residues of an active substance in that product when used in accordance with the conditions of this Extension of authorisation. For those products authorised under Regulation (EC) No 1107/2009 authorisation holders must also tell the other relevant competent authorities of the EC Member States (a list of which is available from the Health and Safety Executive) and the EC Commission. Failure to comply with this requirement is an offence.

Provision of information:

The authorisation holder must comply with all requests for information required by, or on behalf of, the Secretary of State, the Scottish Ministers or the Department of Agriculture and Rural Development in Northern Ireland in accordance with Regulation (EC) No 1107/2009.
